Have you served as a judge or justice? What did you learn from that experience, and what do you believe are the most important qualifications for judges or justices?

Justice Whitener has served a s Judge for seven years before her appointment to the Supreme Court. She believes the most important qualifications for both positions are the ability to listen, to be impartial and to make well-reasoned decisions based on the rule of law. Justice Whitener has been very active locally, nationally, and internationally and speaks often on human rights, access to justice, and the rights and responsibility of the judiciary in ensuring the rights of all that appear before the court to basic dignity and respect in judicial proceedings.

How would you advocate for more equity in our State's justice system?

Justice Whitener is co-chair of the Washington State Minority and Justice Commission. She serves on the Office of Civil Legal Aid Oversight Committee (OCLA) and is a former chair and co-chair of the Washington State Superior Court Judges' Association (SCJA) – Equity and Fairness Committee. Justice Whitener is is a judicial member of the Advisory Council for the QLaw Association of Washington and is also a judicial member of the Washington Women Lawyers. In 2016 then Judge Whitener did a TedxPOS Talk titled "Claiming your identity by understanding your self-worth" where she discussed different labels of disenfranchisement that are used to limit a person's potential.

What ideas do you have to make our judicial system more open, transparent, and responsive?

Justice Whitener continues to speak at professional educational seminars on Implicit and Explicit Bias, Diversity Equity and Inclusion, Judicial Philosophy, Sexual Orientation and the Legal Profession, Judicial Ethics, Overcoming Intolerance, and Diversity in the Law. Promoting and encouraging creating a diverse judicial system requires having different voices at the table.

How do you balance the judicial principle of *stare decisis*, or adherence to precedent, with a rapidly changing society and transformations in our society's understanding of justice?

Justice Whitener believes in just treatment because JUST TREATMENT is Justice. Education is key in addressing precedent and when it is appropriate to have it adapt to changing times. Technology is one area that has allowed the legislature and the judiciary to address disproportionalities embedded in our current system. Technology has allowed others to make the case for change as problems can be seen in real time making it difficult to discredit the information.
