### Situation in Ukraine:

**Congressman Adam Smith** 

37th LD Democrats Membership Meeting

- The U.S. policy approach is to do what we can, without broadening the war. We need to find "off-ramps" to get the war to stop.
- 2022 election: Control of House and Senate is on the line in 2022; sets the platform for 2024.
- Redistricting: Some good news: May be possible to pick up seats, rather than losing. This is the result of hard work.
- Passage of infrastructure bill has been good news.
- · Kim Schrier race is all-important. Please support.
- Patty Murray will also face a significant re-election challenge.
- Question regarding where to donate for Ukraine?
   Answer: Red Cross is a good start.
- Opportunities for peace rather than war? Answer: Diplomacy and development.
- Question regarding defense spending. Answer: Did not support a 10% defense spending cut because it seemed unnecessary. Thinks it is important to have a strong military in order to have a deterrent effect.
- Question requesting statement of support for Elisa Loncon, the Mapuche woman chosen to lead the drafting of Chile's new constitution. Follow-up is requested.

- Member of Minority Justice Commission
- Appointed to Oversight Committee for Legal Aides
- · On the Board of Easter Seals
- In this community for more than 30 years

# **Endorsement committee recommendations and voting demonstration**

Rory O'Sullivan & Keith Gardner

# Recap by Rory O'Sullivan:

- A request was made to convene an ad hoc committee to review our endorsement process and make recommendations for improvement.
- The goal was for a process more accessible to voters and candidates.
- As a result of the review, many changes were suggested to increase ease of use and make improvements.
- One suggestion is the institution of a more permanent endorsement committee
  which would determine in advance which candidates are eligible for endorsement
  and collect reference materials on those candidates. Side note: Vote Builder
  assets may not be used to support candidates who identify as members of
  another party (not Democrat).
- If there is only one candidate, a vote for unanimous acclamation is entertained.
- Races with 2 or more candidates are subject to vote by ballot.

# Provisions of new proposed rules:

- In races where there's a vote, the vote will take place over the 48 hours AFTER the LD meeting. Primarily online, through a secure Google form.
- The 48-hour voting period is intended to increase inclusiveness.
- People who request a hard-copy ballot will be accommodated.
- Suggest that the 60% threshold be maintained.
- Rank-order preference will be allowed.
- If a candidate receives 60% of the vote after first ballot, endorsement is made.
- Otherwise, the fewest-voted candidate is dropped for second ballot, etc.
- If no candidate achieves 60%, there's a possibility for dual endorsement voting at the subsequent monthly meeting.
- A vote for no endorsement is also possible.
- Attendees at the LD meeting can make motions for endorsement, but <u>all</u> members will have the opportunity to vote (whether or not in attendance).

### Question:

Will we be able to support non-Democratic candidates?

### Answer:

Vote Builder access will be removed if we use those assets to support a member of another party.

### Question:

To confirm, part of the reason for convening this committee was to address our lengthy voting process, right?

### Answer:

Yes. 2 recommendations address that: 2-day voting and the ranked-choice ballot.

# Question:

How would judicial candidates be handled?

Answer: The rules are slightly different for judges, as compared to partisan offices. (We can still endorse judicial candidates.)

(Demonstration by Keith Garner of option to modify ballots as needed during the meeting.)

# Rory O'Sullivan:

At the end of meeting, ballots can be modified to delete unanimous ballots, leaving multi-person races, or races with at least one candidate plus a motion for no endorsement.

Ranked choice voting is optional, but not necessary. (OK to just vote for one if desired.)

### Michael Wolfe:

Motion for no endorsement must be formally moved. No endorsement must be "treated like a candidate."

### Question:

In the tally, is it 60% of remaining ballots, or 60% of all voters?

### Rory O'Sullivan:

60% of the people who voted in that race. (That's the voting threshold.)

(Explanation of ranked-choice voting.)

### Question:

Regarding paper ballots?

### Answer:

Online voting is encouraged, but at in-person or hybrid meetings, a paper ballot would be available for those at the meeting. A post-meeting hard-copy ballot process has not yet been fully worked out.

King County Superior Court Candidate Justice Kristin Ballinger

- Appointed a few months ago
- · Family of public servants
- Has been a prosecuting attorney
- · Worked with Skagit Tribe on treaty rights
- Now in Dependency Court (foster kids)

# Seattle Municipal Court Candidate Cat McDowell

- Appointed in 2020
- From Ohio
- Has been in the community since 1997
- Initially in private practice; joined public sector in Seattle
- Part of Remote Access Work Group
- Worked to reduce implicit bias in jury selection)

# Stephanie Gallardo

Running for Congress in 9th Congressional District

- Daughter of refugees
- Intends to center schools and affordable education
- Intends to center affordable housing
- Intends to elevate diversity
