Which elements of the Build Back Better Act do you think are the most important for our country? How would you achieve their enactment?

The Back Better Act is a much needed and necessary investment. It contains important measures to address the greatest existential crisis of our time — climate change — while creating good paying union jobs and building a sustainable, resilient economy. It contains the largest investment to combat climate change in our country's history that would be a crucial first step to put the United States on a path towards decarbonizing all sectors of our economy

I have long considered growing inequality to be one of the defining issues of our time. We need to grow our economy in a more equitable way and address the growing wealth disparities across the world, leveling the playing field for working families. That is why I believe the provisions to make universal pre-k and affordable child care possible, and increase taxes on corporations and the wealthy, are critical components of the Build Back Better Act. The housing investments, expanded child tax credit, and universal paid family and medical leave are also vital to promoting economic opportunity and reducing inequality.

What voting rights / election practices must be available for all voters in all 50 states and what will you do to make sure those are available to all voters by the time of the 2024 Presidential Election?

As an elected official I have and will continue to support policies that work to include more people in the democratic process. I am a cosponsor of the John Lewis Voting Rights Advancement Act that has now passed the House of Representatives, which will institute protections to combat voter discrimination and help restore some critical protections of the Voting Rights Act. I also strongly believe in vote-by-mail elections, such as what we have here in Washington state. The COVID-19 pandemic has further demonstrated the value and importance of a universal vote-by-mail system. Increased voting accessibility is just one way that I can help support marginalized groups to have a greater voice in the political process. I will continue to encourage and support marginalized people to run for local office so that their communities feel empowered to get involved.

Climate change is an urgent environmental and humanitarian crisis in the US and around the world. How would you use your office to enact aggressive measures to mitigate climate change (while ensuring climate justice) through various policy areas (e.g. environmental, transportation, land use, regulatory policy), and what specific policies have you supported?

Climate change is the greatest existential threat we face as a country. I am a proud supporter of the Green New Deal and have consistently supported legislation in the House that would reduce our carbon footprint, invest in renewable energy options, and build a green infrastructure. I firmly believe that we must pass the climate change provisions in the Build Back Better Act to transition away from fossil fuels and decarbonize all sectors of the economy.

Through my role as the Chairman of the House Armed Services Committee, I have been able to push the Department of Defense to address the threat of climate change in both planning to mitigate its impact and reducing its own greenhouse gas emissions. This includes helping lead the passage of legislation to increase the Department's research and development on clean energy technologies such as battery storage, promote the use of renewable electricity to power DOD installations, and reduce emissions across all of the services.
