I am seeking endorsements from all of the labor organizations in King County. I am also in the process of gathering additional judicial, lawyer, and community member endorsements.

Please describe your legal background and experience? What pro bono work have you done in the last 5 years? (please list)

I served as a public defender for over 22 years and represented individuals charged with crimes ranging minor offenses to murder, as well as children and parents who were involved with Child Protective Services. I supervised the misdemeanor, contempt of court, and misdemeanor appeals units. I have served as a District Court Judge since 2016, during which time I have presided over the first Community Court. I currently preside over King County Regional Mental Health and Veterans Courts.

As a sitting judge, I am prohibited from practicing law, and thus, pro bono work is not available to me. However, I currently serve as the Regional Director for the National Association of Women Judges. The association is engaged in projects and judicial education that address human trafficking, conditions and education for women in prison, and outreach to students interested in legal and judicial careers. I currently serve on the human trafficking committee. Pre-pandemic, I assisted in gathering volunteers and coordinating two women's conferences at the Mission Creek Women's Correctional Facility. I regularly volunteer for mock trial competitions and served as co-chair and chair of the Regional Law, Safety and Justice Committee.

What do you believe are the most important qualifications and qualities for justices and judges? What is your experience serving as a judge/justice, pro tem, or within the judicial system and how will this inform your perspective on the bench?

I believe that a judge must genuinely like people and must treat all people with dignity and respect. I believe that a judge must be a good listener and be able to administer decisions in a manner that allows a litigant to understand the reason for the decision. I believe that a judge must be able identify the particular challenges, needs, and perspectives of individuals who appear for them. I believe a judge must be trauma-informed. I believe a judge must have the courage to evaluate a decision and reconsider a decision that was incorrectly decided. I believe a judge must fight for the independence of the judiciary.

I have served as a King County District Court Judge since May, 2016. I have described my experience on the bench in a previous question. I learn something new every day, and continue to self-evaluate my philosophy and approach to justice. I recognize and value the importance of working with stakeholders, and hope to continue to learn from these experiences. I am open to exploring new ways in which to expand therapeutic courts and alternatives to incarceration, while ensuring community safety, individual accountability, and increased access to justice.

How would you further equity and access to justice for all in the legal system? Provide specific examples of what you have done or commit to doing to further this goal.

I currently serve on our court's Equity and Social Justice Committee. One of our recent tasks was to identify and request approval for the translation of a variety of court forms in identified languages. We identified frequently used languages and prioritized forms most often used by pro se litigants, in order facilitate easier access to justice for individuals whose primary language is not English. Our committee has been creating and facilitate educational sessions/presentations entitled Silence=Acceptance. The presentations have focused on promoting educations and awareness of challenged faced by various communities of color. I serve on a statewide diversity committee. One of our current projects is gathering and evaluating the availability of alternatives to incarceration across the state in all jurisdictions and assessing the reasons for lack of alternatives. Our goal is to eliminate "justice by geography". Our committee also facilitated a statewide pro tem training geared toward increasing diversity on the bench.

Judges are expected to fairly apply the law and perform all duties without bias or prejudice. Please provide examples when you have realized and self-checked your own privilege and/or bias or encouraged others to point out to you your own implicit biases?

We are all effected by our life experiences, and have biases formed by those experiences. We must open ourselves to awareness and acknowledgement that bias exists, not only within individuals but within the systems where we work. One factor that contributes to bias is fear of those who we do not understand, whether that be an individual whose experiences we have not experienced, or of a particular community to which we have not been exposed. I strive to foster an environment within my court that allows staff and litigants to express themselves without fear of retaliation. I strive to continue to educate myself about implicit biases. I have called out a prosecutor for what I viewed as disparate treatment of an individual of color. I volunteered to participate in a Harvard study aimed at evaluating my judicial decisions as they relate to racial disparity in bail decisions. We are still in the process of coordinating the feasibility of gathering data for this study. Our therapeutic court team will be participating in an equity and inclusion training.

How would you address the disproportionate impact of sentencing, punishment, and incarceration in the criminal legal system on Black, Indigenous, and Communities of Color, marginalized, and other vulnerable communities and how would you work to address it? Please provide specific examples (alternatives to incarceration, bail reform, etc.)

The expansion of alternatives to incarceration is the first step in addressing the disproportionate impact on Black, Indigenous, and Communities of Color, and other marginalized communities. In King County, we currently utilize the C.C.A.P. and E.H.D. programs as alternatives to incarceration. The therapeutic courts provide an evidence-based therapeutic response for individuals who have behavioral health challenges. By offering services focused on addressing treatment for behavioral health issues and a supportive court environment which holds individuals accountable for their behavior, we offer an alternative to traditional punishment-based responses to behavior. I believe the answer to bail reform would be a robust pre-trial services program that could address concerns over likelihood of failure to appear, could provide voluntary services for individuals with treatment needs, and could provide accountability pre-trial. When an individual is incarcerated, their ability to maintain a job, to participate in their community, and to maintain their dignity is interrupted and serves to perpetuate behaviors that contribute to recidivism.
