I have been a Seattle Municipal Court (SMC) Judge since 2011. I have been the Presiding Judge at SMC since March of 2020.

In addition to my presiding judge administrative duties, I hear cases in Veteran's Treatment Court and General Trial court. I have also heard cases in Community, DV, and Mental Health courts.

I received my J.D. from Seattle University School of Law in 1989. I started out as a public defender with Associated Counsel for the Accused (ACA), where I worked for 14 years as a staff attorney and then alternately as a supervising attorney in the SMC unit, the Misdemeanor Appeals unit and the Juvenile Court unit. I left ACA to start my own firm in 2003.

I am a member of a number of legal organizations including Washington State Bar Association, King County Bar Association, Loren Miller Bar Association, Washington State Racial Justice Consortium, as well as the District and Municipal Court Judges Association where I serve on the Bylaws and Long-range Planning committees, and as the chair of the Diversity Committee. I have been a Board member of a number of community organizations, including the Compass Center, RDLL, SEED, and Seattle University Law Alumni Board.

I have been a judge in Seattle Municipal Court since 2011, which precludes my involvement in politics. I am currently unopposed. My approach is to find opportunities to introduce myself to groups of voters. For judicial positions, these interactions are limited to the year in which the judge appears on the ballot. I plan to seek endorsements from the legislative districts again this year, regardless of whether or not I have an opponent. I believe these groups have the most direct outreach and provide opportunities for the voting public to learn more about the judges who appear on the ballot.

Please describe your legal background and experience? What pro bono work have you done in the last 5 years? (please list)

I have been in the legal field for over 33 years. I worked as a public defender for 14 years. I then ran my own law firm for nearly 8 years while also serving also serving as a pro-tem judge in various courts and teaching trial advocacy at the University of Washington. During my years as an attorney, I was active in both legal and community organizations. Since becoming a judge, my activities have been predominantly in the legal field.

In addition to my duties as a judge, I serve on several committees of the District and Municipal Court Judges Association (DMCJA); I am on the Bylaws and Long-range Planning committees, and I chair the Diversity Committee. I am one of three DMCJA representatives participating in the Washington State Racial Justice Consortium. The Consortium was launched in 2021 following a Washington State Supreme Court letter recognizing systemic racism in the courts and challenging the judiciary "to administer justice and support court rules in a way that brings greater racial justice to our system as a whole."

What do you believe are the most important qualifications and qualities for justices and judges? What is your experience serving as a judge/justice, pro tem, or within the judicial system and how will this inform your perspective on the bench?

I am in my twelfth year as a judge; prior to that, I served as a judge pro tem for six years in various courts throughout the Puget Sound area. In addition to being knowledgeable about the law and qualified as a fair and impartial jurist, a judge must be respectful, a good listener and communicator, and above all, ethical in their practices. A judge should exemplify stability and poise to everyone who enters their courtroom. I believe judges should be compassionate, hardworking, and have integrity. I also believe that compassion and community safety can coexist.

Throughout my legal career as a trial attorney, I had a reputation for being knowledgeable, ethical and prepared. As a judge, I apply these same traits in my courtroom. I make sure to be prepared on cases that come before me by reading the pleadings and briefs ahead of time. I start with a fresh and open mind for each case and try to communicate as much to the parties that come before me. I have found that people relax more when I assure them that their case is heard on its own merits.

How would you further equity and access to justice for all in the legal system? Provide specific examples of what you have done or commit to doing to further this goal.

I have always been a proponent of access to justice dating back to my work as a legal intern at Evergreen Legal Services where we focused on renter's rights. Access to justice should be addressed by the legal community with the support of the general public. By educating the public on the importance of the courts and how the work performed therein affects the greater community, the public is more likely to voice their support for adequate funding for the courts and court-related services. One example of my efforts to further access to justice is that I ensure interpreters are present in the courtroom for hearing impaired and non-English speaking individuals so they can understand what is happening in their case.

It is also imperative to take time to explain to people who are representing themselves (pro-se litigants) how the judicial system works, and, more importantly how the local court works. In all cases, but pro-se cases in particular, it is in everyone's best interest for the court to have stated what is expected of those appearing before the court and what they can expect from the court.

African American males are not given privilege in this society. Thus, I do not take the privilege I have as a judge for granted. Bias, on the other hand, is something that everyone has; we should constantly seek to address our biases. My bias comes from being a man. I was fortunate to have had a strong and loving mother who taught me to respect not just myself as an African American male, but also to respect women. This carries over to the importance I place on how we treat people in the criminal justice system.

Knowing the impact of bias and prejudice, I self-check for this as well as get feedback from my staff and fellow judges to assure that people are treated fairly in my courtroom.

As presiding judge of Seattle Municipal Court, I make sure discussions, policies, and procedures confront and seek to reduce or eliminate racism and other forms of bias. I am proud to be a member of the Washington State Racial Justice Consortium, which intends to make real progress in dismantling structural racism in the justice system through both its intentional internal process and its recommendations for external reform.

How would you address the disproportionate impact of sentencing, punishment, and incarceration in the criminal legal system on Black, Indigenous, and Communities of Color, marginalized, and other vulnerable communities and how would you work to address it? Please provide specific examples (alternatives to incarceration, bail reform, etc.)

I believe judges are a check on the system when it comes to sentencing, punishment, and incarceration. I regularly check plea deals that come before me to ensure equity is taking place. Judges generally accept the recommendations agreed to by the prosecution and defense. However, when those recommendations do not fit with the case as presented, the recommendations should be scrutinized further. In such situations, I give the parties a chance to answer my questions about their agreement and I explain to them the problem(s) I see and why I am thinking about not following their recommendations.

I have given sentences that go against the status quo of incarceration. In those cases, I have imposed community service, substance abuse treatment, anger management, and/or work crew instead of jail/incarceration. I have given credit for jail-time served and, for minor offenses, have closed a person's case so they can make a fresh start. I believe in therapeutic courts where a judge is part of a team that looks for alternative methods as a sanction, and more importantly, looks to address the root causes of a person's behavior, such as drug addiction or homelessness.
