For the past decade I have had the privilege of being an educator in the South end of Seattle. Most recently, I served for 5 years as a High School History and Multilingual Learners teacher at Foster High School in Tukwila School District. I have held positions ranging from an after-school program coordinator, a bilingual Instructional Assistant, to a full-time classroom teacher, and now substitute teacher. In my second year of classroom teaching, I was elected to the Board of Directors for the largest labor union in the country, the National Education Association. I have been an active member of local, state and national labor movements for nearly a decade, since I first joined The Seattle Education Association (SEA) in 2013 as a Paraprofessional Bilingual Instructional Assistant at Martin Luther King Jr. Elementary in the Rainier Valley. Since I became a teacher in the Tukwila School District, I immediately took on leadership roles in my local and state union. I have served as a local building representative for my high school, and was also elected to the Board of Directors for our state educator union, the Washington Education Association (WEA). For the past three years I have served as an elected leader to the Board of Directors for the largest labor union in the country, the National Education Association. In my role as an NEA Board Director I have fought nationally to increase educator pay and allocate additional resources to early career educators and paraprofessional workers. I have also fought to remove police from schools, including Student Resource Officers. Most recently, I spearheaded an effort on our state Board of Directors to allocate the largest sum of money in our union's history to mutual aid and community led non profit organizations seeking to address the immediate material needs of communities most impacted by COVID-19. I organized and led a group of our Directors in distributing these \$300,000 to 54 organizations across our state. Finally, I served as the Chair of the statewide WEA Early Career Educator Committee, where I lead a group of 30 educators within their first five years of the profession to create contract language that benefits our needs as early career educators, plan and implement best practice strategies for classroom communities, and create systems and structures that address the problem of retention as it relates to supporting educators of color.

There were many elements of the BBB Act that were critical for the people in our country. I was sad to see BBB stripped of its historic power through conferencing and negotiation. In its existing state, I believe the most critical element of BBB is expanding access to free universal child care. At the inception of BBB, free universal childcare would have been provided for every child in the nation. After negotiations it has been reduced to 6 million children (sizable and still a win). When elected, I hope to author legislation that will fund pre-school centers at every elementary school in the nation that has room to spare. This will create cohesion from pre-school to elementary school for all students. I will work with members of Congress on both sides of the aisle to advance legislation that meets the needs of all children in our country.

What voting rights / election practices must be available for all voters in all 50 states and what will you do to make sure those are available to all voters by the time of the 2024 Presidential Election?

Democratizing our system in simple, universal ways that are robust to future voter-suppression efforts is an essential step towards a better future. I support a broad and powerful attempt to improve our electoral process, by reducing the corrupting influences of corporate money and partisan gerrymandering, and protecting against many forms of voter suppression.
