April 2022 new rules have been working, according to feedback, but the timing of endorsements has been difficult.

Special guest, Rory O'Sullivan: Proposed changes simplify process; he explained rank choice voting. It will eliminate the opportunity for dual endorsements for ballot measures but he does not consider that significant.

Q: Can't we get to 60%? Top 2 votes eligible for endorsement at May meeting. Relatively unlikely to give a dual endorsement, Rory agreed.

Discussion followed, pro and con.

Vote on changes to standing rules (endorsement process): in favor to adopt new language: 18 in favor. Against: 6. Motion passes.

Pro: Gwen feels a dual endorsement is worthless. She wants anything that leads to less confusion.

Con: Bob Rosenberger: He wants dual endorsement so he's against this change.

Pro: Lynn McKay: This is the best way to give voters information.

Con: Joanna Cullen: She wants reassurance of what kind of report we are getting, the tally. Rory addressed that issue.

Pro: Nancy Truitt Pierce: It was hard to do the digging for just one candidate so this is a help.

Con: Marietta Zintak: She thinks we are getting lazy with online meetings. We have to start meeting in person so we can do dual endorsements.
